Making Home Made Cleaners Can be Deadly

Did you know mixing household chemicals can be extremely dangerous?

With the widespread of COVID-19 or Coronavirus, people are doing everything in their power to keep their environments clean. With cleaning products flying off of the shelves in retail stores, there are extreme dangers to mixing household chemicals. Most chemicals **should not** be mixed with anything **but** water to dilute the solution.

According to the Centers for Disease Control and Prevention, people should frequently clean common touched surfaces, such as door knobs or handles, tables, countertops, light switches, sinks and faucets.

When it comes to having a clean and safe environment, **DO NOT MIX** the following:

- Bleach + Vinegar = Chlorine Gas.
 - This can lead to coughing, respiratory problems, burning and watery eyes.
- Bleach + Ammonia = Chloramine.

Workplace Safety Solutions

- This can lead to shortness of breath, chest pains and irritation to the eyes and skin.
- Bleach + Rubbing Alcohol = Chloroform.
 - This is highly toxic! Can cause damage to the nervous system, lungs, kidneys, liver, eyes, and skin.
- Hydrogen Peroxide + Vinegar = Peracetic / Peroxyacetic Acid.
 - This is highly corrosive and can irritate the eyes, skin and respiratory system.
